比較政治經濟透過比較法研究政治經濟，比較研究的焦點在國家系統層次變項與其他層次變項間的因果關連，而不在政治經濟理論流變的差異。一般進行比較研究的理由大致包括以下數點：比較研究可以增加各國的系絡知識、透過比較可建立適當有意義的國家分類、可以比較研究進行假設檢驗、以及可透過特定通則預測其他國家的發展。

考量政治經濟學範疇及理論的多元與混亂，以及比較政治經濟研究議題的龐雜，本課程採取兩種不同的探討方式：其一、結合理論途徑與特定取向，探討比較政治經濟的若干重要宏觀理論，如國家論、制度論、政策網路等。與傳統政治經濟流派關注的焦點不同，這些理論是當代比較學者以實證角度探索跨國異同的重要途徑，因此必須適度掌握。其二、針對某些重要的政治經濟現象，以比較途徑深入探討，如侍從體制、統合體制、福利國家等，以獲取基本的比較參照觀點。透過主要理論與重要議題的雙重學習，本課程預計修課同學可學習到基本比較方法及重要理論，並透過比較法瞭解政治經濟學可能的發展趨勢。

選修本科的同學修課義務如下：

1. 每週皆須於課前參閱該週指定文獻，自 Week IV 開始每位同學自選 5 週，針對其中一篇文章繳交一千字以內的摘要，合計繳交 5 份（內容必須包括主要論證及批判性的評述，不得超過一頁；同一週摘要不能繳交 2 篇以上；）。
2. 回答教授上課口頭提出的問題。
3. 針對重要比政大師進行報告，另自選一週進行口頭報告。
4. 參加期中考試 (Take-home)
5. 學期末每人繳交一份研究報告(不得少於八千字，必須為國家間的比較，或具備比較意涵的個案研究)

學期成績評估方式如下：上課報告及討論 15%、摘要 15%、期中考 30%、期末報告 40%。

所有指定文獻如摘自特定書籍，請自行影印或推派代表負責影印；如為期刊論文，請自行自圖書館內期刊中影印。
